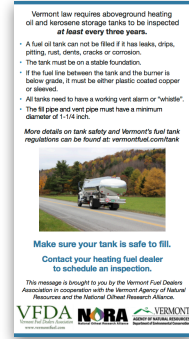

Vermont Aboveground Storage Tank (AST) regulations require heating oil and kerosene tanks that pose a risk of leaking or spilling to be re-tagged and placed out of service. Fuel dealers are prohibited by law from filling a red tagged tank. The Vermont Agency of Natural Resources maintains an online database of red tagged tanks. Red Tag Sticker: Visibly designate a tank as non-compliant with these red tag stickers. Easily sticks to fill pipe or tank and marked with a pen.

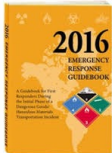

Inspection Tag: The Vermont Fire Code requires all fuel fired heating appliances in public buildings to be inspected at least every two years by a certified heating fuel technician. These generic inspection tags meet this requirement.



Heating Vent Sign: The Vermont Fire Code requires through the wall vents for fuel fired heating appliances to have signage in public buildings. These weatherproof heating vent signs meet this requirement.



Emergency Response Book: Federal regulations require emergency response information in trucks that transport hazardous materials. This book, along with hazmat shipping papers, is one way to meet this requirement.



Flood Brochure: Safety guidance for propane and oilheat consumers.



Member Sticker: Proudly display your VFDA membership on your door, window or truck.

AST Brochure: Tri-fold consumer education brochure that describes AST regulations for new and existing oilheat and kerosene tanks.
